EMD & Tender Fee:

Earnest Money Deposit (EMD) & Tender Fee : Bidder(s) will have to provide EMD of **Rs.4000.00** (Rupees Four thousand only) & Tender Fee of **Rs.525.00**(Including GST) with their offer by Demand Draft drawn in favour of "WBCMPF Ltd, Mother Dairy Calcutta" payable at Kolkata. **The Drafts of "EMD" & "Tender Fee" should be prepared by two separate drafts (not by a single Draft).**

SUPPLY:-

Supply should be made over four to six months part by part as per our Purchase order.

RATE VALIDITY:

Rate:

Rate should be quoted per piece basis. GST % , HSN code of material should be mentioned clearly in the quotation. Price break up should be given.

Price basis & delivery place:

F.O.R Mother Dairy Calcutta, Store basis. Supply should be made at our store at Dankuni.

Placement of Order and Delivery:

Order will be placed on successful bidder as early as possible and delivery is to be done as mentioned in the purchase order at Mother Dairy Calcutta, Dankuni.
